



REACH Status of Tronox®, TiONA®, TiKON™ and CristalACTIV™

Registration

All volumes of Tronox®, TiONA®, TiKON™ and CristalACTIV™ titanium dioxide products placed on the European Economic Area (EEA) market by Tronox and its affiliated entities have been registered, according to the requirements of Regulation (EC) 1907/2006 (REACH) as amended, by an EEA-based Tronox affiliate as a manufacturer/importer or by an only representative appointed by a non-EEA based Tronox entity as manufacturer.

Non-Tronox importers into the EEA of Tronox products may have their own registration obligations under REACH. Customers requiring further information about such imports should contact us at ChemProdSteward@tronox.com.

Titanium dioxide is not classified as hazardous according to Regulation (EC) No. 1272/2008 as amended. Therefore, no restrictions for Downstream Use arise under REACH. In an effort to best support our customers, Tronox gathered information from Downstream User associations and individual customers relevant to the application of titanium dioxide and included this information in our REACH registration dossier.

Substances of Very High Concern (SVHC)

Under REACH, Article 57 the European Chemicals Agency (ECHA) , maintains a list of Substances of Very High Concern (SVHC) which include those that are classified as carcinogenic, mutagenic or toxic to reproduction category 1 or 2 according to Regulation (EC) No. 1272/2008 ('CLP'), Persistent, Bioaccumulative and Toxic (PBT), or very Persistent and very Bioaccumulative (vPvB) according to the criteria in Annex XIII of the REACH Regulation, and/or identified, on a case-by-case basis, as likely to cause serious effects to human health or the environment of an equivalent level of concern as those above.

To the best of our knowledge, Tronox®, TiONA®, TiKON™ and CristalACTIV™ titanium dioxide products do not contain substances listed on the candidate list of Substances of Very High Concern (SVHC)¹ as amended at levels above 0.1% w/w. Also, to the best of our current knowledge, these products do not contain any of the substances included in the Annex XIV ("Authorisation List")² or Annex XVII (Restricted Substances)³ of REACH.
